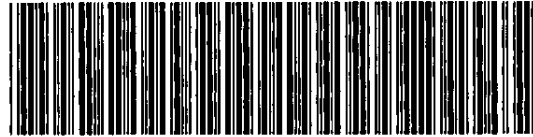

PURPOSE


The undersigned authorized officers of **COMMUNITY ASSISTED AND SUPPORTED LIVING INC.**, hereby file this Amendment as follows:
