ARTICLES OF INCORPORATION
OF
HOUSE OF COUTURE INC.
A FLORIDA NOT FOR PROFIT CORPORATION

Article 1. Name. The name of the Corporation is HOUSE OF COUTURE INC.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the Corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. This Corporation is organized for charitable, educational, literary, and scientific purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue law. The specific purpose of this corporation is the raising of funds through contributions and the auctioning of couture lines (unique items of apparel) the proceeds of which to be donated to selected charitable organizations engaged in works related to either AIDS or the homeless.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members or one or more classes, who shall be admitted in such a manner and who shall have such rights and privileges as set forth in the Bylaws, but who shall not have the right to vote. Article 5. Initial Registered Agent and Office. The initial registered agent and the registered office is:

Article 6. Initial Board of Directors. The initial Board of Directors shall have three members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws, but shall in no case be less than three.


Article 7. Officers. The officers of the Corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.

Article 8. Incorporators. The name and address of the incorporator of the Corporation is Christiun Urquijo, 1239 E. Los Olas Boulevard, Fort Lauderdale, Florida 33301.

Article 9. Nonstock Basis. The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Non For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the Bylaws.

Article 10. Corporate Address. The street address of the Corporation's initial office is 1239 E. Los Olas Boulevard, Fort Lauderdale, Florida 33301.

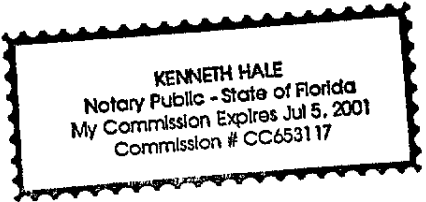

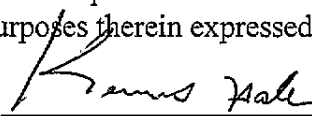

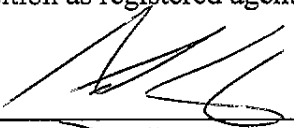
