We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights privileges and annuities of a corporation not for profit.

ARTICLE I

The name of this corporation shall be:

ARTICLE III

The object, business and purpose of this corporation is nonpolitical and shall be devoted to promoting the Word of God, preaching, teaching, living and exemplifying the work of God, through the Lord Jesus for the salvation of all mankind, without reservation to color, creed or nationality; to promote a spirit of brotherhood and a closer association between the members of the organization; to instruct in the gospel, to safeguard and transmit to posterity the purity and righteousness of individual freedom, and the teaching of our Order, as well as to teach the same to our individual members and to the community at large; and to assist in charity of any nature deemed beneficial and to raise funds for carrying the same into effect in any manner allowed by the Constitution and the by-laws of the Order, and permitted under the laws of the State of Florida and the Constitution of the United States of America.


