

### ARTICLES OF INCORPORATION

OF

# CHARISMATIC ORTHODOX CHURCH, INC.

### ARTICLE I. CORPORATE NAME

The name of this corporation is: CHARISMATIC ORTHODOX CHURCH, INC.

### ARTICLE II. PRINCIPAL OFFICE

The principle office for this non-profit corporation is: 784 Viscaya Avenue, St. Augustine, FL 32086.

### ARTICLE III. PURPOSES

The purposes for which this organization is organized are exclusively religious, and charitable within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future law of the United States Internal Revenue Law.

### ARTICLE IV. TERM OF EXISTENCE

This corporation shall have perpetual existence commencing upon filing of these Articles.

### ARTICLE V. CORPORATE STATUS

The corporation is incorporated as a not for profit corporation under the provisions of Chapter 617, Florida Statutes.

### ARTICLE VI. MANNER OF ELECTION OF BOARD OF DIRECTORS

The number of the initial board of directors shall be not less than 3 nor more than 5. The directors shall be elected once a year by majority vote of the members of the corporation. Membership shall be regulated by the by-laws of the corporation.

# ARTICLE VII. INITIAL REGISTERED AGENT AND STREET ADDRESS

### ARTICLE X. STOCKS

The corporation shall never have nor issue shares of stock and no part of the corporation shall be distributable nor distributed to its members, directors, or officers.

# ARTICLE XI. POWERS OF CORPORATION DEFINED

The corporation is allowed to accept gifts, bequests of money and or/personal and real property for the endowment of its purposes and objectives. The corporation shall also be allowed to manage any such donations as it sees fit. The corporation may hire employees if necessary, and hold harmless any director or agent of the corporation for their acts on behalf of the corporation.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the internal revenue code of 1986, or the corresponding provision of any future united states internal revenue law.

# ARTICLE XII. DISSOLUTION OF ORGANIZATION

Upon the dissolution of this organization, if ever, the assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the internal revenue code of 1986 or its corresponding section of any future united states internal revenue law,

or shall be distributed to the federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
