The directors shall be elected by members of the organization at the annual meeting.

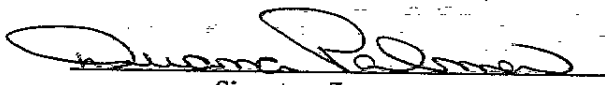
