ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of Real World Ministries Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment adopted: Article 3. Purpose.

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under The Nonprofit Religious Corporation Law, and within the meaning of Section 501 (c)(3) of the Internal Revenue Code exclusively for religious purposes. The specific purposes of this corporation are:

- 1. To proclaim the good news of salvation by faith in our Lord Jesus Christ and His full Gospel by any suitable method or media which includes, but is not limited to, the following:
 - a) Establishing and operating an evangelistic outreach for the salvation of lost souls, using personal evangelism, television, radio, crusades, conventions, preaching, outdoor activities, missions, and other Christian methods.
 - b) Assisting and furthering the task of providing Biblical teaching and principles to all who will hear through printed material, speakers, electronic media, and any other method that is now or may become available.
- To do all things necessary, expedient, or appropriate to the accomplishment of any of the objects and purposes for which this corporation is formed.

Notwithstanding any of the above, no substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign, including the publishing or distribution of statements, on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
