ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name

The name of the corporation shall be: **EBENEZER Development Ministries Incorporated**

ARTICLE II - Principal Office

The principal place of business shall be: **3501 Inverrary Boulevard, Fort Lauderdale, Florida 33319**; and the mailing address shall be: **P.O. Box 24426, Fort Lauderdale, Florida 33307-4426.**

ARTICLE III - Purpose(s) Of The Corporation

The purpose of the corporation shall be:

- (a) To promote *spiritual development* through financial support and inter-denominational collaborations with Churches, evangelistic associations, Bible college and seminaries, missionary organizations, Christian media and other religious entities and individuals;
- (b) To provide *social development* services at the community level in the areas of rehabilitation and employment and housing for the homeless, disaster relief assistance, care for the aged and for orphans, promotion of positive social values among young people and the delivery of qualified advice and counseling on family issues;
- (c) To facilitate *economic development* primarily among minority peoples and other ethnic groups in the United States and among governments and peoples of Third World countries in the areas of micro-enterprise, industry, agriculture, skills and business management training, technology utilization, community cooperatives, grants procurement assistance and micro-financial services;
- (d) To encourage human *intellectual and professional development* primarily in rural areas and inner-city communities through individualized academic programs in cooperation with colleges, universities and professional associations.

ARTICLE IV - Manner of Election or Appointment of Directors

The manner in which the directors are appointed is: The initial directors are selected and appointed by the founder and chairman of the corporation. Subsequently, president of the corporation may nominate a person who meets the criteria to be set out in the by-laws of the corporation on the recommendation of the Secretary. The nomination shall be endorsed by a majority of the total number of directors after which the Chairman may effect the appointment of additional director(s).
