ARTICLES OF INCORPORATION OF FRIENDS OF GOOSE POND, INC.

ARTICLE I

The name of the corporation is Friends of Goose Pond, Inc. It is a not for profit corporation.

ARTICLE II

ARTICLE III

The purpose of Friends of Goose Pond, Inc. is to promote the long term good of Goose Pond and matters connected to that long term good, including without limitation, fund raising and advocacy.

ARTICLE IV

The method of election of directors shall be as provided in the bylaws. The bylaws shall control each matter not controlled by Chapter 607 or 617, Florida Statutes, or these Articles and shall be adopted, amended or repealed as provided therein.

If the corporation is dissolved or otherwise terminated, the assets shall be distributed to the then membership or to a 501(c)(3) corporation with similar purposes or to a state agency.


