The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: TAMAMI YOUTH BASKETBALL ASSOCIATION, *INC.*

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are);, none of which are intended for monetary or other benefit of any of its members or private shareholders: - to organize and operate a youth basketball league, where none is available, thereby lessening the burden on area government to provide a much needed service.

-to instruct and train youth in the community, for the purpose of improving and developing their capabilities while promoting their civic awareness and responsibility through active participation in sports.

-to engage in any lawful purpose or purposes not for pecuniary profit.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: there shall be (3) three directors.

The affairs of the corporation shall be managed by the Board of Directors, which will be elected by its membership in accordance with the Bylaws. The Board of Directors will elect from among themselves a President, a Secretary and a Treasurer. Such Officers shall be appointed in accordance with the Bylaws.

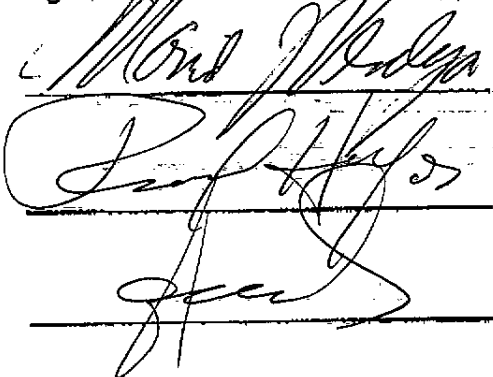
