ARTICLES OF INCORPORATION
of
XLR-8's GirlSoccer, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I **NAME**

The Name of the Corporation shall be **XLR-8's GirlSoccer, Inc.**

ARTICLE II **PRINCIPAL OFFICE**

The principal office of this corporation is: 6967 Sunset Drive S.
S. Pasadena, FL 33707

ARTICLE III **PURPOSES**

The specific purposes for which the corporation is organized are:

- 1) To oversee development of girl's youth soccer teams,
- 2) To train each of it's players, preparing them to compete at higher levels as they age,
- 3) To generate revenue for our team through donations and various fundraising efforts,
- 4) To disburse funds for equipment, tournaments, training, travel and other soccer-related expenses.

ARTICLE IV **MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is through voluntary participation, determined annually after the selection of the team from a pool consisting of the player's parents. The number of directors may be either increased or decreased from time to time by the bylaws, but shall never be less than three. Directors will not be compensated for their efforts in running the team.
