ARTICLES OF INCORPORATION OF CHRISTIAN ACTION ASSOCIATION INC.

ARTICLE I NAME

THE NAME OF THIS CORPORATION SHALL BE: CHRISTIAN ACTION ASSOCIATION INC.

ARTICLE II DURATION

THE DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

ARTICLE III PURPOSE

THE PURPOSE OF THIS CORPORATION IS HEREBY SET FORTH TO WIT:

1. THIS CORPORATION IS A NON-PROFIT CORPORATION, TO EXERCISE ALL RIGHTS TO WIT PERMISSIBLE UNDER 501(C)3 OF THE INTERNAL REVENUE CODE, TO ACQUIRE GOODS AND SERVICES FOR THE PURPOSE OF CHARITABLE USE: TO LEND, TO PURCHASE, TO LEASE, TO CREATE, TO FRABICATE, TO SELL TO IMPORT OR EXPORT SUPPLIES AND GOODS OR ANYTHING THAT COULD BE EMPLOYED ACCORDINGLY THAT WOULD BE INCIDENTAL OR NECESSARY TO THE CHARITABLE PURPOSE OF HELPING THOSE WHO CANNOT HELP THEMSELVES AND/OR TO DISTRIBUTE THE SAME TO ORGANIZATIONS FOR THE SAME PURPOSE HEREIN.

2. TO HELP AND/OR ESTABLISH EDUCATION: RELIGIOUS AND SCIENTIFIC, AND TO FEED, CLOTHE, PROMOTE THE HEALTH OF THE LESS FORTUNATE.

ARTICLE IV REGISTERED AGENT

THE INITIAL REGISTERED OFFICE SHALL BE LOCATED AT 45 N.E. 46 ST. MIAMI, FLORIDA 33127.

AND THE INITIAL REGISTERED AGENT SHALL BE: RONALD JEAN.

ARTICLE V DIRECTORS

THE NUMBER OF DIRECTORS IN THIS CORPORATION SHALL BE NO LESS THAN ONE AND NO MORE THAN SEVEN.
