ARTICLES OF INCORPORATION

OF

THE OLD HOLY ROMAN CATHOLIC CHURCH, IN

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **THE OLD HOLY ROMAN CATHOLIC CHURCH**, **INC***., (hereinafter, "Corporation).

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly as a church.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 600 Orange Avenue, Saint Cloud, Florida 34769 and the mailing address is the same.

ARTICLE 4 - INCORPORATOR
