ARTICLE I - NAME

THE NAME OF THIS NON-PROFIT, TAX EXEMPT CORPORATION SHALL BE THE FRIENDS OF THE MICCOSUKEE CANOPY ROAD GREENWAY, INC. ITS PRINCIPAL OFFICE SHALL BE LOCATED IN TALLAHASSEE, FLORIDA, AT 9704 ABBEY ROAD. ITS MAILING ADDRESS SHALL BE 9704 ABBEY ROAD, TALLAHASSEE, FLORIDA 32309

ARTICLE II - PURPOSE

THE PURPOSE OF THIS NONPROFIT, TAX EXEMPT CORPORATION IS TO PROTECT AND PRESERVE THE MICCOSUKEE CANOPY ROAD GREENWAY AS A PUBLIC PARK OWNED BY THE STATE OF FLORIDA BY CREATING A CULTURE OF COLLABORATION WITH PARTNER ORGANIZATIONS, SCIENTISTS, LAND MANAGERS, PLANNERS, ELECTED OFFICIALS AND DEVELOPERS TO ENSURE CITIZEN USERS ARE PROVIDED A SAFE RECREATIONAL EXPERIENCE. IN ORDER TO CARRY OUT THIS PURPOSE, THE CORPORATION WILL MONITOR MANAGEMENT PLANS REQUIRED BY STATUTE AND RULE, ENDEAVOR TO ENSURE A COLLABORATIVE RELATIONSHIP WITH THE LEON COUNTY DIVISION OF PARKS AND RECREATION, THE LAND MANAGERS, AND TO KEEP ELECTED OFFICIALS INFORMED OF THE CRITICAL NEEDS OF THE GREENWAY.

ARTICLE III - PARTNERS AND COLLABORATORS

PARTNERS AND COLLABORATORS INCLUDE OTHER NONPROFIT ORGANIZATIONS REPRESENTING TRAIL USERS, HABITAT SPECIALISTS FROM DISCIPLINES SUCH AS FORESTRY, GRASSLAND MANAGEMENT, CONTROLLED FIRE, TRAIL DESIGN, DEVELOPMENT AND MAINTENANCE, LAND MANAGEMENT, INVASIVE SPECIES CONTROL, EDUCATORS, BIRD HABITAT SPECIALISTS, ADJOINING LAND DEVELOPERS AND PRIVATE INDIVIDUALS WHO SERVE AS GREENWAY VOLUNTEERS. THE CORPORATION SHALL PURSUE WHEN NEEDED THE ADVICE AND COUNSEL OF EXPERTS AND TO OFFER OPPORTUNITIES FOR INTERESTED EXPERTS TO WORK WITH THE CORPORATION TO IMPROVE ITS CAPACITY TO PROTECT AND PRESERVE THE GREENWAY.
