AMENDMENT TO ARTICLES OF SECRETARY OF STATE SECRETARY OF STATE OF

Pursuant to the provisions of Section 617.1006, Florida

Statutes, this corporation adopts the following amendment to its ___
articles of incorporation:

FIRST: Amendments adopted:

Article VII shall read as follows:

Amendment of the Articles of Incorporation requires the approval of at least 75% of the lot owners.

Article VIII shall read as follows:

Upon dissolution of the Association, the assets shall be dedicated to a public body, or conveyed to a non-profit organization with similar purposes.

Article IX shall read as follows:

Every person or entity whose is a record owner of any lot is entitled to membership and voting rights in the association.

Membership is appurtenant to, and inseparable from, ownership of the lot.

Article X shall read as follows:

As long as there is Class B membership, annexation of additional properties, mergers and consolidations, mortgaging of common area, dedication of common area, dissolution and amendment of the Articles, requires prior approval of HUD/VA.

The date of the amendment's adoption is 22nd day of SECOND: June, 2000.

The amendments were approved by a majority vote of THIRD: the Board of Directors and adopted by at least 2/3 of the members present at the meeting on June 22, 2000. The number of votes cast was sufficient for approval.
