ARTICLES OF INCORPORATION  
OF  
NEW SONG CHURCH OF GOD, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

ARTICLE ONE: NAME - The name of the proposed corporation shall be: NEW SONG CHURCH OF GOD, INC. The principal place of business of the corporation shall be: 17236 Shady Hills Rd., Brooksville, Florida 34610.

ARTICLE TWO: DURATION - The duration of the corporation is perpetual.

ARTICLE THREE: PURPOSE OF BUSINESS - The purposes for which New Song Church of God, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE FOUR: The provision for qualification of members and the manner of their admission is to be provided for in the bylaws.

ARTICLE FIVE: INITIAL REGISTERED AGENT AND STREET ADDRESS -

ARTICLE SIX: DIRECTORS - The number constituting the initial  
Board of directors of the corporation is four: Sebastiana Ramos,

Hills Rd., Brooksville, Florida 34610, Maritza De Jesus, 1500 River  
Reach Dr., #277, Orlando, Florida 32828 and Cristobal De Jesus,  
1500 River Reach Dr., #277, Orlando, Florida 32828. Directors will be  
elected as stated in the bylaws.

ARTICLE SEVEN: This corporation is organized under a non-  
stock basis.
