ARTICLES OF INCORPORATION OF

1. The name of the Corporation is TRANSITIONAL GARDENS, INC., a Florida not-for-profit corporation (the "Corporation").

2. Article III of the Articles of Incorporation of the Corporation is hereby amended to add the following language:

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code.

3. This Amendment was unanimously approved by the Directors of the Corporation on March 31, 1999.

4. There are no members or members entitled to vote.
