## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TRANSITIONAL GARDENS, INC.

- 1. The name of the Corporation is TRANSITIONAL GARDENS, INC., a Florida not-for-profit corporation (the "Corporation").
