ARTICLES OF INCORPORATION

of

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments adopted:

Article I Name.

The name of the corporation shall be changed from "Pinellas County Amateur Radio Emergency Services, Inc." TO "Pinellas County Amateur Communications Service, Inc."

Article II Principal Office

The principal place of business and mailing address of this corporation will be in Pinellas County, Florida.

Article III Purposes

The specific purpose(s) for which the corporation is organized is (are):

A. Pinellas County Amateur Communications Service, Inc. (change) is a Not for Profit Public service organization which consists of FCC Licensed Amateur Radio Operators who have voluntarily registered their qualifications and equipment for communications duty in the public interest when disaster strikes. Pinellas County Amateur Communications Service, Inc.(change) is organized to train, educate and administer these volunteers in that effort and to that end.

B. Pinellas County Amateur Communications, Inc. will endevor to support numerous public service organizations which include but are not limited to(change): The Tampa Bay Chapter of the American Red Cross which has two offices in Pinellas County, The Salvation Army of Pinellas County, The National Weather Service's SKYWARN (severe Weather Spotter) Program through their offices in Ruskin, Florida and many other public service organizations who during times of disaster in Pinellas County have a need for the communications services provided by the corporation's volunteer amateur radio operators.

ARTICLE IV Manner of Election of Directors

The manner in which the directors are elected or appointed is:

- A. The President shall be elected by a majority of the membership at the annual meeting, OR special meeting should the presidency become vacant, to serve a one year term. (change)
- B. The Board of Directors for the Pinellas County Amateur Communications Service, Inc. shall consist of the following as a minimum: the President, the Secretary, and the Treasurer. The President shall be elected by the membership at the annual meeting. The President when elected, appoints ALL officers and directors as needed to accomplish the purpose of the Corporation. (change)
