Article II of the original Articles of Incorporation has been deleted in its entirety and the amended Article II that follows is substituted:

### ARTICLE II - CORPORATE PURPOSE

The purpose of this Corporation shall be to actively seek local, state and federal grant monies for the preservation of historical sites and buildings located in south Columbia County, Florida, including, but not limited to, the old Fort White Cemetery. Said Corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

The first paragraph in Article XII of the original Articles of Incorporation has been deleted and the following is substituted and begins # 1.

#### ARTICLE XII - PROHIBITED ACTIVITIES

The Corporation shall not:

1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)
