The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE III PURPOSE(S)**

- A. The purposes for which this corporation is formed are exclusively charitable and educational, and more specifically:
1. To raise the economic, educational and social levels of Central Florida residents in social and economic distress (underemployed and unemployed). Including those making the transition from welfare to work.
  2. To expand affordable housing opportunities available to said Central Florida residents by constructing, rehabilitating, and acquiring decent, safe and sanitary housing for said Central Florida residents who otherwise would not be able to find or afford a suitable place to live.
  3. To assist in employment development for the advancement of the said Central Florida residents.
  4. To provide cultural, educational, and socially enriching programs for the personal development and sense of well being of said Central Florida residents.
  5. To provide health, hygiene and diet information for the physically development of said Central Florida residents.
  6. To provide transportation, childcare and other supportive services to said Central

Florida residents

7. To provide motivational, business and economic development workshops to stimulate social and psychological stability in said Central Florida residents.
8. To aid families of said Central Florida residents, who share guardianship rights for the children of said Central Florida residents, through counseling and other supportive services.
9. To exercise all other rights and powers conferred upon corporations formed under the General Nonprofit Corporation Law of the State of Florida, provided, however, that the Corporation shall not engage in any activities or exercise any powers, including those specifically mentioned herein, that are not in furtherance of the specific and primarily charitable and educational purposes of the Corporation.

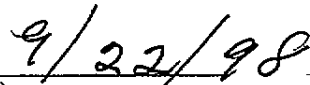
