## **FAAVCO BOARD OF DIRECTORS STATEMENT OF FACT**

## STATE OF FLORIDA COUNTY OF VOLUSIA

The FAAVCO Board of Directors, after being first duly sworn and cautioned, deposes upon their oaths and say:

- We are the legitimate Board of Directors of the Filipino -American Association of Volusia County, Florida, Inc. as currently recognized by the State of Florida.
- We are all over the age of 18. We are not laboring under any disabilities, and we are competent. We have personal knowledge of the facts and matters stated below that would be admissible as evidence in a court of law.
- 3. Pursuant to Section 3.02, page three, of the FAAVCO Bylaws titled "Election", "There shall be a meeting every two years to conduct an election of officers." There are no provisions in the Bylaws that allow the elections to be denied for any reason.
- 4. Pursuant to the Bylaws, the definition of "Officers" includes those who typically serve as the Board of Directors. The term "Officers" will be rereferred to hereafter as the Board of Directors.
- 5. Due to the Association's election cycle, elections were due to be held before 5/18/20. However, the Board of Directors at that time, hereafter referred to as

5/18/20. However, the Board of Directors at that time, hereafter referred to as

the illegitimate/former board, failed to hold them even though several

members of the Association requested them multiple times. Because of that

Board's dereliction of duties, and intentional failure to hold elections, they

illegitimately remained in power.

6. More importantly, the President at that time had just finished her second term

and continued to hold herself out as President up until recently, even though

pursuant to the same section of the Bylaws, "The elected President and Past

Presidents shall be eligible for no more than two (2) two-year term

consecutively, or in different years."

7. Based on the foregoing, the Former President's last legitimate term expired

on May 18th, 2020, which means that she had no authority to act on

FAAVCO's behalf even though she has done so for the past two years and

remained in power illegitimately.

8. Because elections were not properly held in May of 2020, and the Bylaws

contain no provisions otherwise, the remainder of the Board also did the

same and remained in power illegitimately.

9. From May of 2020, until May of 2022, no activities, meetings, or gatherings

were held for the membership although they were requested multiple times.

10. At the conclusion of the most recent second year term, which was May of

2022, several association members again reached out to the

illegitimate/former board on multiple occasions and requested elections

pursuant to the Bylaws, again with no response.

elect its leadership for yet a second time, the membership exercised its

authority, and held an election on June 25th, 2022, after giving proper notice

pursuant to the Bylaws, and a new Board of Directors was properly elected.

None of the illegitimate/former board members attend the election even

though they were properly noticed and given the opportunity.

12. Upon being properly elected, the current board attempted to gain access to all

Association assets and records but was denied by the illegitimate/former

board.

13. Since that time, the illegitimate/former board has purposefully hindered the

new board from exercising its duties and responsibilities over the Association.

They have also continuously held themselves out to be the current board,

which has created confusion in the membership.

14. After the current board was properly elected, the illegitimate/former board

then attempted to terminate their membership in the association without the

authority to do so under the Bylaws.

15. Shortly thereafter, the illegitimate/former board held a second election on or

about August 13th, 2022, in an attempt to subvert the election of the new

board. However, on July 20th, 2022, and before the election could be held,

the new Board of Directors held an Emergency Meeting, and unanimously

voted to terminate the membership of the illegitimate/former board members

pursuant to Article X, Section 10.02 because they had engaged in conduct

that was prejudicial to the interest of the Association.

In short, the illegitimate/former board members were no longer members of

because they intentionally denied the membership their right to hold elections

from the previous term and remained in power illegitimately. The Notice of

Termination of Membership was sent to all illegitimate/former board members

before the second election.

17. As of the writing of this Affidavit, the State of Florida has recognized the

current board of directors as those who have sworn to this Affidavit and

signed below. However, the board members that were illegitimately elected

as a result of the second election have filed paperwork with the Department of

State in an attempt to be recognized as the current Board of Directors.

18. Based on the foregoing, the legitimate FAAVCO Board of Directors is as

currently recognized by the State of Florida at the time this Affidavit was

executed.

19. Any changes to the Articles of Incorporation, Bylaws, or any other corporate

documents without the written consent or approval of the Board of Directors

who have subscribed their signatures hereto are null and void.

20. Any persons holding themselves out as FAAVCO board members, other than

those who have subscribed their signatures hereto, are not legitimate board

members and have no authority to act on behalf FAAVCO.




