ARTICLES OF INCORPORATION FOR

MISION HISPANA DEL CENTRO DE ADORACION INC.

ARTICLE I NAME

The name of the corporation shall be: MISION HISPANA DEL CENTRO DE ADORACION INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address shall be: 11801 West Broward Blvd. Plantation, Broward County, Florida.

ARTICLE III PURPOSES

The main purposes of this corporation are:

1. To promote the worship and the exaltation of God in our meetings and in our lives.
2. To proclaim the gospel of salvation in Jesus Christ by our lives, our involvement to meet the social and spiritual human needs in our community and by the corporate meetings.
3. To equip and to motivate our members to live a life according to the moral and spiritual principles of the Word of God.
4. To represent to the Hispanic community the emphasis on the redemptive grace of God of The Worship Center Baptist Church Inc.
5. To solicit, collect, accumulate and administer real and personal property, or both, in whatever form, including cash funds from public and private sources, and, subject to the restrictions and limitations, set forth, to use and apply the whole or any part of the income therefrom, and the principal thereof, exclusively for religious, charitable, literary, scientific, or education purposes either directly or by contributions to organizations That qualify as exemptions organizations under Section 501 (c) (3) of the Internal Revenue Code and the Regulations issued pursuant thereto as then now exist or as they may hereafter be amended.

ARTICLE IV ELECTION OF DIRECTORS

All directors must be members of MISSION HISPANA DEL CENTRO DE ADORACION INC.

Their election shall take place at a meeting called for that purpose, of which at least one week's public notice has been given. An affirmative vote of three fourths of those members present will validate the choice. The Directors shall be replaced or elected for a new term at the annual election of officers of the corporation.

#### ARTICLE V LIMITATION OF CORPORATE POWER

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

The corporation shall be empowered to enter into contracts, hold and convey title to real and personal property, and exercise all powers permitted to a corporation not for profit and the other laws of the state of Florida, not inconsistent with the general objectives enumerated herein. All funds of the Corporation and any moneys from its operation shall be used in the furtherance of the purposes set forth hereinabove.

No part or the net earnings of the Corporation shall insure to the benefit of, or to be distributable to, any director or officer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation in furtherance of one or more of its purpose (s), and no director or officer of the Corporation or any private individual shall be entitled to share in the distribution or any of the corporate assets on dissolution of the Corporation. No substantial part of the activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding of any provision of these Articles of Incorporation, the Corporation shall not conductor carry on any activities not permitted to be conducted or carried on by any organization exempt from taxation under Section 501 (c) (3) of the Internal Revenue Code and the regulations issued pursuant thereto as they now exist or as they may hereafter be amended; or by an organization, contributions to which are deductible under Section 107 (c) (3) of the Internal Revenue Code and said Regulations as they now exist or as may hereafter be amended.

## ARTICLE VI DISSOLUTION OF THE ORGANIZATION

Upon the dissolution of MISION HISPANA DEL CENTRO DE ADORACION INC., the Trustees shall, after paying or make provision for payments for all the liabilities of the Mission, dispose of all assets of the Mission, to The Worship Center Baptist Church Inc.

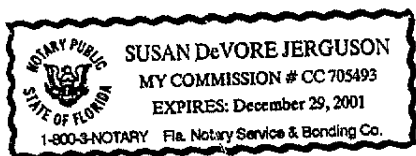
