# ARTICLES OF INCORPORATION

OF

## Alaqua Women's Charitable Fund, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I- NAME

The name of this corporation is: **Alaqua Women's Charitable Fund, Inc..**

### ARTICLE II- ADDRESS

The street address of the initial principal office of this corporation is: 2251 Lucien Way, Suite 300, Maitland, Florida 32751.

### ARTICLE III- PURPOSES

The purposes for which this corporation is formed are to assist families in crisis, to support other charitable organizations that assist families in crisis, and to engage in charitable, scientific, or educational activities, all within the meaning of §501(c)(3) of the Internal Revenue Code of 1986, as amended and applicable rules and regulations thereunder (the "Code"), together with all other activities permitted by the Florida Not For Profit Corporation Act which further its exempt purposes, as specified herein, including, but not limited to, the payment of overhead expenses, administrative costs, and reasonable salaries to its members where necessary to carry out the exempt purposes of the corporation. However, no part of the net earnings of the corporation shall inure to the benefit of any member or other individual nor shall any distribution of the corporation's assets be made to any member or other individual, unless such distribution is in furtherance of the exempt purposes specified in this Article.

### ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The method of election of directors will be stated in the corporation's bylaws.

### ARTICLE V- INITIAL REGISTERED OFFICE AND AGENT

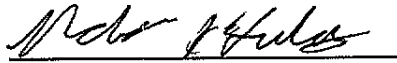
