**ARTICLES OF INCORPORATION
OF
NORTH BREVARD WOMEN'S BOWLING ASSOCIATION, INC.**

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a non-profit corporation in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be:

NORTH BREVARD WOMEN'S BOWLING ASSOCIATION, INC.

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation shall be:

660 N. Dixie Avenue
Titusville, Florida 32796

ARTICLE III

Purposes

The corporation is formed for the following purposes:

A. To include, in a central organization, all qualified WIBC members in an area designated by the Women's International Bowling Congress (the Women's International Bowling Congress [WIBC] encourages the consolidation of small cities into metropolitan groups, thereby making larger and stronger local associations. Cities are advised to consult WIBC for direction). It shall be subsidiary to the Women's International Bowling Congress, which is the parent body, and the provisions of these bylaws shall govern the organization subject to the bylaws, rules and regulations of the WIBC.

B. To fulfill the duties of local associations as required by the WIBC.

C. To maintain and increase interest in the bowling game for its members and to have and exercise a general care and supervision over all activities of its members initiated and/or conducted by the local association as permitted by the WIBC.

D. To promote, conduct and manage an annual tournament for the members of the North Brevard Women's Bowling Association, the results of which shall determine the championships of the association.

E. To conduct this association as a nonprofit organization.

ARTICLE IV

Directors

The manner in which the Directors are elected or appointed is as follows:

The officers and directors (unless the association has provided for an employed secretary or secretary-treasurer and/or league presidents or accredited representatives to serve on the board) shall be elected by ballot at the annual meeting of the association and shall hold their respective offices for a term of two (2) years and until their successors take office. Each term of office starts August 1st following election.

The association shall establish a stagger system so that all officers and directors are not elected at the same time. The stagger system adopted by the association is as follows: Even: President, Secretary/Treasurer, four (4) Directors; Odd: Vice President, Sgt. at Arms, four (4) Directors.

Officers shall be elected by a majority vote.

Directors shall be elected by plurality vote. The election shall be by ballot, except that a voice vote may be taken when the number of candidates does not exceed the number of positions to be filled.

ARTICLE V

Registered Agent

The corporation may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 607.037, Florida Statutes.
