**ARTICLES OF INCORPORATION
OF
IN SISTERHOOD, INC.**

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit business corporation.

ARTICLE I

The name of the corporation ("Corporation") is In Sisterhood, Inc.

ARTICLE II

The existence of the corporation shall begin on the date of filing with the Secretary of State.

ARTICLE III

The principal place of business and mailing address of the Corporation is 830 W. Lakeview Avenue, Pensacola, Florida 32501.

ARTICLE IV

The specific purposes for which the corporation is organized are to provide lesbian support including education, herstory, addressing all-ism issues, and to promote a sense of community. The exclusive purposes of this corporation are charitable, educational and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. This corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

ARTICLE V
