ARTICLES OF INCORPORATION

The undersigned, for the purpose of corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the incorporation shall be: **This congregation of believers shall be known as the Church of God of Prophecy / Living Springs Family Worship Center Inc.**

ARTICLE II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:
6165 Lottie St. Jacksonville, FL 32216-2744

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):
This corporation is organized for general corporate purposes: for the purpose of facilitating and executing the business and activities of the Church of God of Prophecy / Living Springs Family Worship Center, within the State of Florida; to meet the requirements of the laws of the State of Florida in regard to the acquiring, mortgaging and disposition of real estate within the State of Florida; and to conduct any and all business of the corporation with regard to ownership of property. The corporation is organized exclusively for religious purposes within the meaning of Section (501) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Its further purpose is to operate a church institution and to propagate the gospel of Jesus Christ on this earth under the name and style of "Church of God of Prophecy / Living Springs Family Worship Center, Inc." Said church shall be controlled and administered in accordance with the doctrine of the Holy Bible rightly divided, and shall accept the New Testament of the Bible as the rule of faith, practice and teaching.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed are:
Officers shall be appointed by the Pastor / President of the Corporation in a business meeting of the local church for a two (2) year term.
