Incorporation are natural persons, competent to contract, and they
do hereby present these Articles for the formation of a not-forprofit corporation under the Florida Not-For-Profit Corporation
Act.

#### ARTICLE I

The name of this corporation is:

A UNIVERSE OF CHILDREN, INC.

#### ARTICLE II

# NATURE OF BUSINESS

The general purposes for which the Corporation is organized are the following:

- A. To assist qualified families in foster care and placement, domestic and international adoption, and to provide humanitarian and medical aid to children with disabilities, orphanages, and to provide all related social services.
- B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
