

Pursuant to our conversation, I am forwarding the completed Notice of Administrative Dissolution or Revocation to you with a remittance of \$61.25 (Annual Report Fee).

I believe that the confusion stemmed from our filing Amendment to our Articles of Incorporation at the same time we filed our Annual Report. This Amendment corrected an inadequate number of officers and directors for the corporation and was filed in July, 1999. The Annual Report was sent more than once, the last time, simultaneously with that Amendment. No response was received to either our Amendment or Annual Report.
