FUTURE DISTRIBUTION OF THE ASSETS

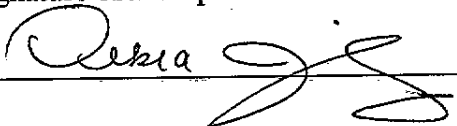
