ARTICLE I - NAME AND ADDRESS

The name of the corporation shall be *Bethel Church in Christ, Inc.* with its place of business at 51 N.E 24th Street, Suite #7, Fort Lauderdale, Florida 33305.

ARTICLE II - CORPORATE NATURE

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE III - PURPOSE

a) To promote the belief in God and Christianity and to engage in any business consistent with the corporations not for profit laws of Florida.

(b) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purpose as set forth in subparagraph (a) of this article.

c) This corporation is organized and operated exclusively for the above state purposes, and not part of any net earnings shall inure to the benefit of any private member.

(d) The activities of this organization are inclusive but not limited to:
