The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: OUR LADY OF SORROWS HELP COMMITTEE, CORP.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 12041 NW 22 Ct. Miami, FL 33167

ARTICLE III: PURPOSE

The specific purpose, inspired by Reverend Father Rafael Pavon Zamora, for which the corporation is organized mainly is to help the people of Nicaragua now, because of Hurricane Mitch destruction and later to help Nicaragua and other underdeveloped countries. The Incorporators wish to hereby recognize and praise Father Pavon Zamora of the Dioceses of Leon, Nicaragua as Founder of this charitable endeavor. No personal benefit whatsoever shall be derived from this corporation to any officer, director or incorporator. Consequently, all things necessary to achieve that purpose are authorized to the corporation, such as, but not limited to, open and close bank accounts, receive donations and pay all ordinary expenses.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: by election among the members of the Board of Directors. The Board of Directors shall consist of not less than three (3) directors at any time. *in the by-laws*

ARTICLE V: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: no limitation.

ARTICLE VI: INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VII: TERM

The term of the corporation is perpetual or until the directors approve its dissolution. At that time any remaining assets, including cash on hand and/or in bank will be transferred to any governmental entity or 501(c)(3) corporation.
