AMERICAN CONSERVATORY OF MUSIC LTD.

PURPOSES AND POWERS

To encourage appreciation of music; to encourage musical performance and the teaching of same; to sponsor or produce musical performances both live and in other media both now and hereafter known; to acquire, equip, and maintain by purchase, lease, or otherwise the necessary resources to support the activities necessary for pursuit of the aims and objects expressed herein.

The aims and objects of this corporation are nonprofit and nonbusiness. No pledge or distribution of assets of this corporation may be made until all debts are fully paid and then only upon its final dissolution and surrender of organization and name; nor shall any pledge of assets or dissolution of the corporation be made except by a voice vote of a majority of all the members with no proxy voting permitted.

This corporation will operate in perpetuity as a tax exempt corporation as defined in Ch. 501(c)(3) of the U.S. Revenue Code; upon liquidation and after payment of all obligations the remaining assets will be given to such other organization or organizations as may have similar aims and objects and which at such time enjoy status as tax exempt pursuant to Ch. 501(c)(3) of the U.S. Revenue Code or such subsequent superseding regulation as may at that time be in effect.
