ARTICLES OF INCORPORATION OF "ROMANIAN RHAPSODY CULTURAL CENTER, INC."

The undersigned, acting as Incorporator for the purpose of forming a not for profit Corporation under the provisions of Chapter 617 of the Florida Statutes, hereby delivers the following Articles of Incorporation for said Corporation to the Department of State of Florida.

Article I

Name

The name of the Corporation is:

Article II

Purpose

The purpose for this corporation is organize are as follows:

A. To receive and to administer funds and to operate exclusively for religious, charitable, scientific, literary or educational purposes the mining of section 501 (c) (3) of Internal Revenue Code of 1986, or compatible provisions of subsequent legislation and to give funds and property from time to time to other organizations to be used or held directly in carrying out one or more such purposes.

B. To acquire, own, purchase, lease, dispose of and deal with real and personal property and interests, either absolutely or in trust therein and to apply gifts, bequests, and devices and proceeds thereof in furtherance of purposes of the Corporation.

C. To do such things and perform such acts accomplish its purposes as the Board of Directors may determine to be appropriate and as not forbidden by Section 5012 (c) (3) of the code, with all powers conferred on not for profit corporations under the laws of the State of Florida.

D. To expose the Romanian / Eastern European culture to the south Florida communities, primarily in Broward County, through our Non-Profit cultural organization, performing arts experiences, educational experience including but not limited to, music, dance, drama, theater programs, creative writing, literature, architecture, painting, sculpture, folk arts, photography, crafts, public media, and history archaeological and natural science museums and the exhibitions of major cultural art forms.

E. To preserve the Romanian / Eastern European cultural diversity, develop and transmit the Romanian and Eastern European heritage to the future generations born here in the USA and to assist the people that have emigrate integrate into the American mainstream.

Article III

Powers

A. The Corporation shall possess and exercise all the powers and privileges granted by Chapter 607 and 617 of the Florida Statutes as they now exist or as they may be hereafter amended, or by any other law of Florida applicable in any manner to not for profit corporations limited only by the restrictions set forth in the Articles of Incorporation and in said Chapter 607 and 617 of Florida Statutes.

B. No part of the net earnings of the corporation shall inure to benefit of, or be distributed to its members, directors, officers, or any other private persons, except that the Corporation shall be authorized and empowered to make pay compensation for services rendered and to make payments distributions in furtherance of purposes set forth in the Articles of Incorporation hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under

Section 170(c) (2) of Internal Revenue Code or the corresponding section of the future federal tax code.

Article IV

NONSTOCK MEMBERSHIP CORPORATION

The Corporation shall be organized as a nonstock membership corporation. Qualifications for members and the manners of their admission to membership in the Corporation shall be as regulated by Bylaws of the corporation.

Article V

Board of Directors

All corporate powers shall be exercised by or under the authority of, and the affairs of the Corporation shall be managed under the direction of, a Board of Directors, exempt as otherwise provided in the Articles of incorporation or in the Bylaws of the said Corporation, or as may be otherwise required by any of the provision of Chapter 607 and 617 of the Florida Statutes as they now exist or as they may be hereof amended. The number of Directors shall be determinate and fixed pursuant to the Bylaws of the Corporation, but shall consist of at least three (3) persons, the manner in which the directors shall be elected, appointed or removed shall be set in the Bylaws.

Article VI

Article X

Term of Existence

This Corporation is to exist perpetually.

Article XI

Desolution

Upon the dissolution of the Corporation, and subject to the provisions of Section 617.05 of the Florida statues as it now exists or as it may be hereafter amended, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, if any, to such organization or organizations existing and operating exclusively for charitable, scientific, literary or educational purposes and at that time qualified as an exempt organization or organizations under the Section 501 (c) (3) of the Code. Any assets not so disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is located, exclusively for such purposes or such organization or organizations, as said the Court shall determine, which are organized and operated exclusively for such purpose.

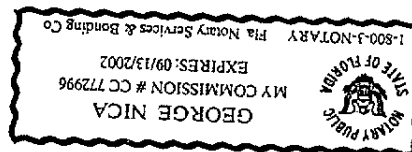
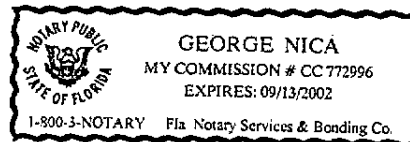

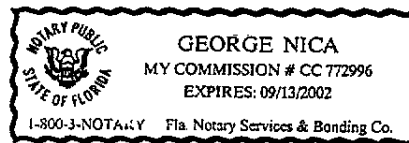
