CHRISTIAN CHURCH FOUNTAIN OF LIFE, INC. hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida statutes, and all amendments relating thereto and hereby adopts the following articles of incorporation:

THE NAME AND ADDRESS

The name of the corporation is, "**CHRISTIAN CHURCH FOUNTAIN OF LIFE, INC.**" with a physical address at 5 Alapha, Davenport, FL. 33836.

ARTICLE II

PURPOSE

INCORPORATION MAY BE PROPOSED AND ADOPTED**



DISTRIBUTION OF ASSETS UPON DISSOLUTION


