

ARTICLES OF INCORPORATION OF

MIAMI DADE LATIN BASEBALL LEAGUE CORP

The undersigned incorporator hereby forms the following corporation under the laws of the state of Florida .

ARTICLE I NAME

The name of the corporation is, Miami Dade Latin Baseball League Corp and its address is 5830 N.W 186 St Suite 102 Miami Florida 33015

ARTICLE II PURPOSE

This non for profit corporation is organized to engage in any arrangement, supervision, and control of amateur baseball tournaments permitted under the laws of the State of Florida

ARTICLE III TERMS OF EXISTENCE


ARTICLE VII

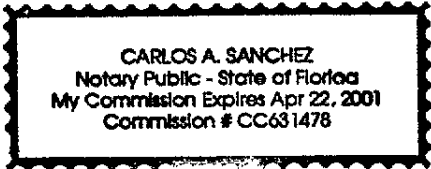
