- ONE:** The name and address of this principal corporation is Salvation House of Praise Ministries, Inc. 620 NE 59th Ct., Ft. Lauderdale, Florida 33334, In Broward County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This corporation is a non-profit religious benefit Corporation and is organized to spread the gospel of Jesus Christ. The corporation is organization under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, economical Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth at Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.


