ARTICLE I - NAME

The name of this Corporation is Cedar River Club of Jacksonville, Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE

The address of the initial principal office of this Corporation is 5700 San Juan Avenue, Jacksonville, Florida 32210.

ARTICLE III - PURPOSE

This Corporation is organized for the purposes of: (1) transacting any and all lawful business not for pecuniary profit; (2) providing the City of Jacksonville with a social club located on the westside of town with the facilities wherein business owners and professionals can meet in an atmosphere conducive to socialization, mutual improvement and fellowship; (3) promoting aquatic and boating sports activities and safety; and (4) developing and fostering fellowship and camaraderie among the Corporation's members and their families.

ARTICLE IV - DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors consisting of not less than five (5) and not more than nine (9) persons. Each director shall be a member of the Corporation.

Directors shall be elected by the members as an annual meeting which shall be held at a time, on a date, and at a place to be fixed by the Bylaws of the Corporation. The manner of their election shall be provided for by the Bylaws.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of this Corporation is 200 East Forsyth Street, Jacksonville, Florida 32202, and the name of its initial registered agent at such address is Bruce J. Fletcher, Esq.

ARTICLE VI - INCORPORATOR

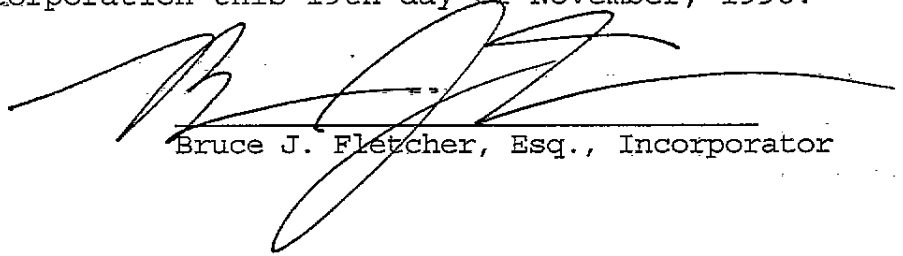

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and

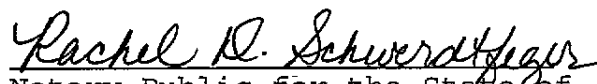
any right conferred upon the members is subject to this reservation.

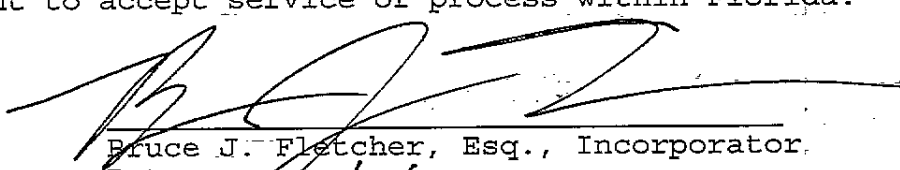

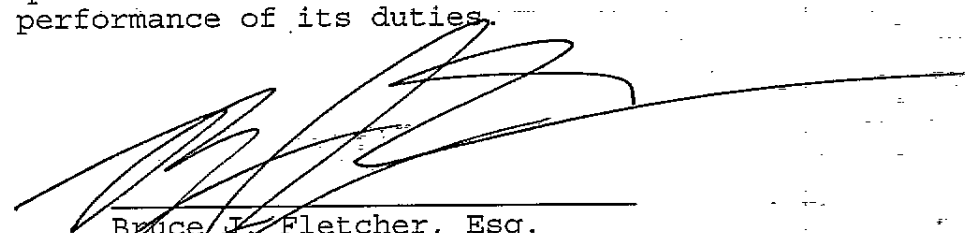
