Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida *Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

1. Article **TWO** is amended to read as follows:

**TWO:** The corporation is organized exclusively for religious, charitable, educational, and scientific purposes under section 501©(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code, including, but not limited to (i) spreading the gospel of Jesus Christ, and providing the following services to the poor and needy: (i) health care services, (ii) service to the homeless, (iii) child care, (iv) programs to aid youth at Risk, (v) tutorial programs for under achiever, (vi) economic development, (vii) housing for low income, (viii) job training, (ix) counseling, (xi) employment opportunities, and (xii) other related services..

2. Delete Paragraph **FIVE (a)**


3. Article **SEVEN** is amended to read as follows:

**SEVEN:**

- (a) No part of the net earning of the corporation shall inure to the benefit of or be distributable to the corporation's officer, directors or private individual, but the corporation shall be authorized and empowered to pay reasonable compensation for service rendered, and to make payments and distributions in furtherance of the purpose set forth in Article TWO.
- (b) No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**The date of the adoption of these amendments was April 17, 2007.**

There are no members or members entitled to vote on the amendments. The amendments were adopted by the board of directors.
