ARTICLES OF INCORPORATION
OF
THE KING'S COURT CHRISTIAN DANCE MINISTRY, INC.

The undersigned, for the purpose of forming a corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is
THE KING'S COURT CHRISTIAN DANCE MINISTRY, INC.

ARTICLE II: DURATION

The period of duration of the corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III: PURPOSE

This corporation is a religious corporation and is not organized for the private gain of any person. A further description of the corporation's purposes is as follows:
to reach people with the gospel of Jesus Christ through the preaching and teaching of the Word; to present various artistic presentations through dance and drama to the body of Christ; and to conduct seminars and workshops for instruction and demonstration.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the Corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

The initial registered office and agent of the Corporation will be Renee' M. Handtke, 13302 Egrets Marsh Dr., Jacksonville, Florida 32224.

ARTICLE VI: INITIAL BOARD OF DIRECTORS

The number of persons constituting the Board of Directors of the corporation is five (5) initially. The method of election of directors is stated in the bylaws of the corporation. The name and address of the person who is to serve as initial director of this corporation is Renee' M. Handtke, 13302 Egrets Marsh Dr., Jacksonville, Florida 32224.

ARTICLE VII: NON-STOCK BASIS

The corporation is organized under a non-stock basis.

ARTICLE VIII: DISSOLUTION

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or local government for exclusive public purpose.

ARTICLE IX: INCORPORATOR

The name and address of the incorporator of these Articles of Incorporation is Renee' M. Handtke, 13302 Egrets Marsh Dr., Jacksonville, Florida 32224.

ARTICLE X: AMENDMENTS

The corporation reserves the right to amend or repeal the provisions of these Articles of Incorporation, or any amendment(s) thereto.

ARTICLE XI: CORPORATE POWERS

The corporation shall have all corporate powers as stated in 617.0302, Florida Statutes.
