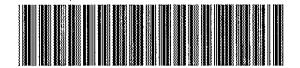

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DATE AMERICAN ACADEMY OF AMBULATORY CARE, INC.

THE UNDERSIGNED, Franz Ritucci, Jr., M.D., President of AMERICAN CE, FLORIDA ACADEMY OF AMBULATORY CARE, INC., a Florida not-for-profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is:

AMERICAN ACADEMY OF AMBULATORY CARE, INC.

ARTICLE SECOND: The first amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Amended and Restated Articles of Incorporation is amended to provide as follows:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be: AMERICAN ACADEMY OF URGENT CARE MEDICINE, INC.
