The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: FELLOWSHIP TABERNACLE, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 121 S. 61 Terrace, Hollywood, Florida 33023.

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):
