The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: IDEOLOGIA Y COMBATE, CORP.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 7870 NW 64 St. Miami, FL 33166.

ARTICLE III: PURPOSE

The specific purpose for which the corporation is organized is to help the people of Cuba to find the democratic and pluralistic way while achieving a much needed national reconciliation. Among the means to achieve these goals is to support the opposition and dissidence in the Island of Cuba, who are peacefully working for the above goals, deprived of any financial resource. No personal benefit whatsoever shall be derived from this corporation to any officer, director or incorporator. Consequently, all things necessary to achieve that purpose are authorized to the corporation, such as, but not limited to, open and close bank accounts, receive donations and pay all ordinary expenses, including those aimed at helping the persecuted opposers, dissidents within the Island or overseas.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: by election among the members of the Board of Directors. The Board of Directors shall consist of not less than three (3) directors at any time.

ARTICLE V: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: no limitation.

ARTICLE VI: INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and the street address of the initial registered agent is: Pedro Rodriguez-Medina 850 E. 40 St. #2 Hialeah, FL 33013.

ARTICLE VII: TERM

The term of the corporation is perpetual or until the directors approve its dissolution. At that time any remaining assets, including cash on hand and/or in bank will be transferred to any governmental entity or 501(c)(3) corporation.

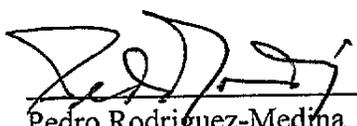
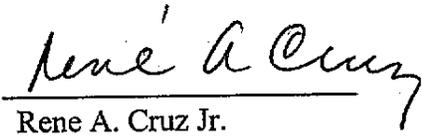
