



ARTICLES OF INCORPORATION  
of



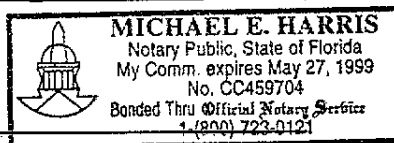
