## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be:

Bright Water Christian Fellowship, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):

This congregation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal revenue Code of 1986 (or corresponding provision of any future U.S. Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, rescue missions, print shops, day care centers, camps, nursing homes, and cemeteries, and any other ministry that the Church may be led of God to establish.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The directors shall consist of at least 3 members, serving 1 year terms. Vacancies in the directors shall be filled by appointment of the pastor and ratified by the board then in office, even though less than a quorum (2+) exists.
