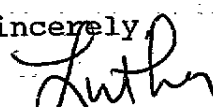

ARTICLE ONE: NAME

The name of this corporation shall be "LOVE, JOY, PEACE, INC."

ARTICLE TWO:
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The location and mailing address shall be 4751 NW 155th Street, Trenton, Florida 32693. The Trustees may change the location of such corporation and the Mailing address by majority vote of the Trustees.

ARTICLE THREE: GENERAL PURPOSE

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE FOUR: OBJECT

Membership requirements in the corporation are set forth in By-Laws adopted by the Board of Trustees.

ARTICLE FIVE: TERM OF EXISTENCE

This corporation shall have perpetual existence subject to the provisions of the laws of Florida and the will of the corporation.

ARTICLE SEVEN: GENERAL POWERS

The affairs of this corporation shall be managed by the Board of Trustees consisting of not less than three persons not more than fifteen persons, having a Chairman, a Secretary and a Treasurer (or a Secretary-Treasurer combined in one office). The Trustees shall be composed of members of the corporation of such numbers as the corporation shall from time to time elect. The Trustees shall be elected by the members of the corporation at the annual meeting, in such manner and for such term as shall be prescribed by the By-Laws of the corporation. The Trustees shall each year immediately following the annual election elect a Chairman, a Secretary and Treasurer who shall hold office for a period of one year or until their successors are elected. Said officers shall have such duties as shall be prescribed by the By-Laws.

ARTICLE NINE: OFFICERS

ARTICLE TEN: BY-LAWS

By-Laws for the government of this corporation may be made, altered, or rescinded by a two-thirds majority vote of the members of the corporation present at any regular or special meeting of the members of the corporation.

ARTICLE ELEVEN: AMENDMENTS

These Articles of Incorporation may be amended by a two-thirds majority vote of the members of the Trustees present at any special meeting or at the regular meeting of the Trustees. Such amendment must have the approval of a majority of the members of the corporation.

ARTICLE TWELVE: REGISTERED AGENT

The registered agent of the corporation is ROBERT A. LANGSTON and the registered office is located at 4751 NW 155th Street, Trenton, Florida 32693. The Trustees may change the registered agent and the office with the approval of the new resident agent by giving notice to the office of the Secretary of State as required by the laws of the State of Florida.

ARTICLE THIRTEEN: DISSOLUTION

Upon dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall, at the time, qualify as an exempt organization or organizations under Section 501(c) (3) of Internal Revenue Code of 1954 or the Corresponding provision of any future United States Internal Revenue Law, as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

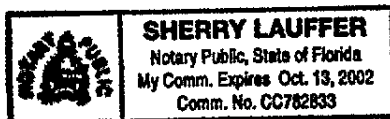
