The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: LIGHTHOUSE ASSEMBLY, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: CLEARWATER, FLORIDA P.O. Box 7214, Clearwater, Florida 33758

ARTICLE III PURPOSES

THIS LOCAL CHURCH IS EXCLUSIVELY RELIGIOUS, AND ITS OBJECT AND PURPOSES ARE TO AID IN PREACHING THE GOSPEL OF THE LORD JESUS CHRIST. IT SHALL HAVE THE RIGHT TO ESTABLISH AND MAINTAIN PLACES OF WORSHIP. IT SHALL HAVE THE RIGHT AND POWER TO LICENSE AND ORDAIN ANY MISSIONARY, EVANGELIST, PASTOR OR MINISTER, SCRIPTURALLY QUALIFIED, WHO SHOWS EVIDENCE OF A DIVINE GIFT AND CALLING OF GOD TO THE SATISFACTION AND APPROVAL OF THE LOCAL ELDERS AND WITH THE SANCTION OF THE WHOLE BODY OF THE CHURCH. IT SHALL HAVE THE RIGHT TO ACQUIRE THROUGH PURCHASE, GIFT, EXCHANGE OR OTHERWISE SUCH PROPERTY, REAL AND PERSONAL AS MAY BE DEEMED NECESSARY FOR CARRYING OUT THE GENERAL PURPOSES OF THE LOCAL CHURCH: TO SELL, BEQUEST, LOAN, OR OTHERWISE DISPOSE OF PROPERTY BELONGING TO THE LOCAL CHURCH: TO RECEIVE MONIES THROUGH GIFTS, OFFERINGS, LEGACIES, OR LOANS FOR THE CARRYING ON OF ITS BUSINESS, AND TO PAY OUT MONIES FOR EXPENSES, PURCHASES, SALARIES, GIFTS, AND LOANS AS DEEMED NECESSARY AND TO EXERCISE ALL THE RIGHTS AND PRIVILEGES GRANTED BY LAW TO RELIGIOUS ORGANIZATIONS.

ARTICLE IV ELECTION OF DIRECTORS

THE MANAGEMENT OF THIS LOCAL CHURCH, SPIRITUAL, RELIGIOUS, EDUCATIONAL, AND TEMPORAL SHALL REST IN THE CORPORATE BODY OF THE LOCAL ELDERS. ANY VACANCY IN OFFICE SHALL BE FILLED ACCORDING TO THE PROCEDURE SET FORTH IN THE LOCAL CHURCH BY-LAWS.
