Articles of Incorporation of the undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

EFFECTIVE DATE
1-4-99

First: The name of the Corporation shall be **The Rainbow's Touch, Inc.**


Second: The place in this state where the principal office of the Corporation is to be located is the City of Bonita Springs, Collier County. The address of the principal office and the mailing address of the Corporation is 42 8th Street, Bonita Springs, FL. 34134.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The method of election or appointment of the Directors will be stated in the Bylaws.

Fifth: The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Sixth: The street address of the Corporation's initial registered office is: 42 8th Street, Bonita Springs, FL 34134. The name of the Corporation's initial registered agent is: Fred G. Daugherty.

Seventh: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Eighth: The effective date of these "Articles of Incorporation" shall be January 4, 1999.
