## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SOUTH SARASOTA COUNTY BALLET EDUCATION PROGRAM,

Pursuant to the provisions and authority granted by Section 617.1006, Florida Statutes, SOUTH SARASOTA COUNTY BALLET EDUCATION PROGRAM, INC., a Florida corporation, hereby amends its Articles of Incorporation as follows:

1. Article 4 - Limitations of Powers - in the Articles of Incorporation of SOUTH SARASOTA COUNTY BALLET EDUCATION PROGRAM, INC. is deleted in its entirety and the following is substituted in lieu thereof:

## ARTICLE 4 LIMITATIONS ON POWERS

- 4.1 <u>General</u>: The Corporation shall have all of the commonlaw and statutory powers of a corporation not for profit under the laws of the State of Florida that are not in conflict with the provisions of these Articles, the Bylaws of the Corporation, the Act and shall have all powers conferred by the laws of the State of Florida necessary or desirable and consistent with Section 501(c)(3) of the Internal Revenue Code of 1986. In furtherance of the objectives of this Corporation, the property of this Corporation is irrevocably dedicated to the exempt purposes of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or any corresponding section of any future Internal Revenue Code.
- 4.2 <u>Distribution of Income; Dissolution</u>: No part of the net earnings or net income of the Corporation shall inure to the benefit of or otherwise be distributed to any Member, Director or Officer of the Corporation, and no Member, Director or Officer of the Corporation shall receive any recurring benefit from the Corporation except such reasonable compensation as may be allowed for services actually rendered to the Corporation and the use, payment or distribution of the net earnings or net income in furtherance of the purposes set forth in Article 3. In the event of dissolution, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive purpose.
- 2. Members are not entitled to vote on this amendment. This Amendment was adopted by the Board of Directors of the Corporation on February 22, 1999.
