Articles of Incorporation of
Seven Day Sabbath, Every Day Jesus, Teaching Ministry Inc.

We, the undersigned subscribers, agree to form a non profit corporation under the laws of the State of Florida, pursuant to these Articles of Incorporation as follows:

Article I

The name of this non-profit corporation shall be : Seven Day Sabbath, Every Day Jesus, Teaching Ministry Inc.

Article II

The principal place of business and mailing address of this corporation shall be : 1321 Silver Street, Jacksonville, Florida 32206.

This corporation shall exist perpetually unless dissolved according to Florida law.

Article III
Purpose

This non profit corporation is organized for the purpose of establishing and maintaining churches, convocation for public worship, missions, schools, and other operations and auxiliaries. Incidental, thereto, and to assist members in achieving the common objective under which this corporation is organized. Nothing in the foregoing shall be deemed as prohibiting the corporation from extending its activities to any related or therewith permissible lawful purpose which may become necessary or desirable for the furtherance of the corporation objectives expressed hereabove.
