The undersigned incorporator, being competent to contract, subscribe to these Articles of Incorporation to form a corporation not-for-profit under the laws of the State of Florida.

ARTICLE I - Name

The name of this corporation shall be Oneness Apostolic Church of Jesus Christ, Inc.

ARTICLE II - Activities

Oneness Apostolic Church of Jesus Christ, Inc. may, and is authorized to, engage in the activities of a church and related activity permitted under the laws of the United States and of Chapter 617, Florida Statutes, and not otherwise constituting a regulated industry in the State of Florida.

ARTICLE III - Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 1221 West Colonial Drive, Suite 200, Orlando, Florida 32804, and the name of the initial registered agent of Oneness Apostolic Church of Jesus Christ, Inc. at that address is J. BROCK McCLANE. The principal office shall be 901 Wages Way, Orlando, Florida 32825.

ARTICLE IV - Directors

A. The initial number of Directors of Oneness Apostolic Church of Jesus Christ, Inc. shall be three (3).

B. The number of Directors may be either increased or diminished from time to time by the Board of Directors or the Shareholders in accordance with the By-Laws of Oneness Apostolic Church of Jesus Christ, Inc.

C. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at any annual or special meeting thereof. The Board of Directors may authorize and require the payment of reasonable expenses incurred by Directors in attending meetings of the Board of Directors.

D. Nothing in this Article shall be construed to preclude the Directors from serving Oneness Apostolic Church of Jesus Christ, Inc. in any other capacity and receiving

compensation therefor.
